The bulls averaged 3.97 over 122 days which is a testament to the performance and conversion ability we have strived for. Also all adjusted weights in the catalog are through Angus Herd Improvement Records (AHIR). We don't feed the bulls hard for a short period and adjust them out to a year.

The open heifers were taken right out of the middle of the replacement pen. This is the best selection of open heifers we have ever offered. The heifer calves did not have creep feed over the summer and have been developed slowly with 5 lbs. of pellets

The cow herd is run much like most commercial operations. With the extended fall and mild winter they were out grazing until Christmas. They winter on chopped hay and Vitaferm alone. Our cattle are not pampered. They have to go out

and work in the pasture and winter well without supplementation. By doing things the way we do, we feel we

have a very functional, performance-oriented, easy-fleshing herd. We are very proud of this sale offering and invite you to the farm at any time to look things over. We would

If a female represented as "safe in calf" at time of sale to a certain bull proves to have been bred to a different bull, the seller shall be obligated to make a satisfactory adjustment on the purchase price to the buyer or, at the buyer's option, refund the purchase price upon return of the animal to the farm of the seller (adjustments shall not be considered to be a breeding fee or an allocation of the purchaser, except that the seller (adjustments shall not be considered to be a breeding fee or an allocation of the purchaser, except that the seller shall be responsibile for transportation costs in excess of the distance between the purchaser's farm and the location where the sale took place.
- 4. If a female sold as "open" proves to be with calf, the purchaser may return the animal to the farm of the seller prior to calving for a refund of the full purchase price or for another animal of equal value, whichever is acceptable to the purchaser. It shall be the obligation of the seller to bear any expense incurred for the transportation.
- 5. Cows with calves at side are presumed to be breeders with no further fertility guarantee.
- 6. White skin or hair shall not be painted or altered. If such painting or alteration has occurred, the buyer may return the animal to the farm of the seller for a refund of the full purchase price or for another animal of equal value, whichever is acceptable to the purchaser. Any expense incurred for transporting the animal shall be the responsibility of the purchaser, except that the seller shall be responsible for transportation costs in excess of the distance between the purchaser's farm and the location where the sale took place.
- 7. If an animal is sold, and at a later date, proves not to be eligible for registration under the Association rules, the seller shall be obligated to make a satisfactory adjustment on the purchase price to the buyer, or at the buyer's option refund the purchase price upon the return of the animal to the farm of the seller. Any expense incurred for transportation shall be the responsibility of the purchaser, except that the seller shall be responsible for the transportation costs in excess of the distance between the purchaser's farm and the location where the sale took place.
- 8. If an animal is sold and through blood tying is proven to have incorrect parentage, as represented by the certificate of registration, and for which parentage can be determined, the seller shall be obligated to make a satisfactory adjustment on the purchase price to the buyer or, at the buyer's option refund the purchase price upon the return of the animal to the farm of the seller. Any expense incurred for transportation shall be the responsibility of the purchaser, except that the seller shall be responsible for transportation costs in excess of the distance between the purchaser's farm and the location where the sale took place.


GENETIC DEFECT GUARANTEE

- 1. All animals are guaranteed not to produce a calf with the following defects for a period of two years from date of sale: Dwarfism, Osteopetrosis (marble bone disease) and Syndactylism (mule foot). This guarantee is effective only under the following conditions: (a) The buyer shall notify the seller in writing immediately upon the birth of a calf suspected of being defective or immediately after determination is made that such calf is defective.
- (b) The seller at his expense shall be permitted, and provided with reasonable opportunity, to obtain blood samples of an alleged defective calf and its sire and dam for the purpose of blood type analysis to establish parenthood.
- (c) The animals will be returned by the buyer to the seller at the buyer's expense; provided the animals meet the health requirements of the seller's state.
- (d) The return of the purchase price in connection with a defect producing animal shall be deemed full satisfaction and settlement.
- 2. In the event there is a dispute as to whether or not a calf is defective, the "Determination" referred to in paragraph I,a) above shall be made by a person or persons acceptable to both the buyer and seller, and in the event that the buyer and seller cannot agree on the selection of such person or persons, then each of them shall appoint a representative to make the determination. In the event that such representatives fail to agree, a third person selected by the representatives of the buyer and seller shall make the determination.
- 3. Registration certificates issued after January 30, 1979, for animals which, prior to issuance of the certificate, have been reported and verified as carriers of recessive genetic defects or genetic factor or have tested free of certain genetic defects or genetic factor contain the following codes relative to such defect. S-Syndactyly; H-Double Muscling; D-Dwarfism; M-Osteopetrosis; HI-Heterochromia Irides; HG-Horn Gene; R-Red; X-Multiple Defects, Check List for Kind; F-Tested For Defect Printed Without Producing Abnormal Calves; GDF-Produced 35 or more calves from Daughters Without a Genetic Defect or Genetic Factor. The absence of any such notation on a pedigree of an animal, in a sale catalogue, does not establish that the animal in question is not a carrier of any such genetic defect or genetic factor.

RIGHTS AND OBLIGATIONS

- The above terms and conditions of sale shall constitute a contract between the buyer and seller of each animal and shall be equally binding upon both. Each sale or resale of an animal constitutes a separate transaction.
- Neither the sponsoring association, the sale manager, nor any other person connected with the management of the sale, assumes any liability, legal or otherwise.

Enrolling in AngusSource

Become a Producer Participant

- To be eligible to supply calves to the AngusSource program, producers must have Angus-sired calves that originate on their operation, use registered Angus bulls, have management practices that allow for the identification of calves that are Angus-sired, and keep calving records that document the birth date of the oldest calf.
 - Complete the AngusSource Producer Participant Enrollment Form and Agreement. Download forms at www.angussource.com or request by calling AngusSource.
 - These forms must be completed and returned via fax or mail to AngusSource before enrolling calves.



Complete Training/Enroll Calves

Calves must be enrolled by the ranch of origin, sired by a registered Angus bull and have known group age. There is a \$50 fee for each enrollment. Visual tags are \$1/tag, matched-pair sets (radio frequency identification (RFID) button plus matching visual tag) \$3.25/set. Allflex tag applicator is \$17.50 (must use the red Allflex applicator to apply these tags).

- Complete training and enroll calves by calling AngusSource.
- Provide enrollment information to AngusSource and submit any required records.
- Choose a tag option. For \$1/head, receive a full-size laser-ink printed visual ear tag with customized in-herd management number. A RFID-matched pair (visual tag and an electronic tag) is available for \$3.25/head.
- Tags will be delivered 7-10 business days after enrollment is processed. Tag only those calves enrolled in AngusSource.



Print/Customize AngusSource Verification Certificate

- AngusSource Verification Certificates are generated for each lot of enrolled calves. Certificate includes the genetics, source and group-age.
- Access and customize/print certificates online, at www.angussource.com or by calling AngusSource.
- Customize the AngusSource Verification Certificate for feeder calves or replacement females. If marketing information is included, a listing will be activated on the AngusSource Web site for up to 90 days prior to sale date and is e-mailed to nearly 600 potential buyers.
- Print certificate to provide information to potential buyers.
- Buyers may request certificate by contacting AngusSource if one is not provided at the time of purchase.
